_____ Roll cage or cageless vehicles (circle A or B):

A. For a roll cage to be considered adequate, it must have at least 6 points of contact and contain at least 2 door bars on both sides of the vehicle. **NOTE:** while a roll cage is not required, it is highly recommended and the lack of one brings additional stipulations with it.

B. Cageless tandem of two or more vehicles is allowed at the discretion of the event staff. It is not a default allowance and can be given or taken away based on observation of driving ability and track etiquette. **NOTE:** no passengers are allowed in cageless tandem.

Failure to abide by these rules may cause you to lose driving privileges at the current and/or future events.
